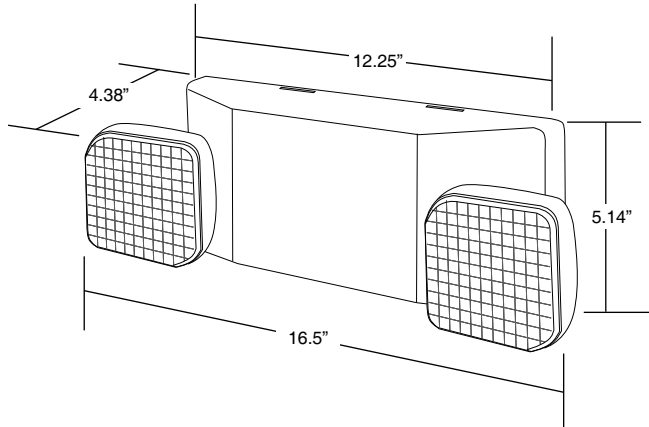

Entire unit (excluding lamps) carries a 3-year Full Warranty.

Suggested Specification

The contractor will install the Lightalarms _____ battery unit. The emergency lighting system shall consist of fully automatic equipment with 2 glare free emergency heads. Each unit shall contain a fully automatic, solid state charger with test switch and AC-on pilot light. The unit shall contain a solid state transfer circuit and low voltage disconnect circuit. The battery shall be 6 volts with a design life of 8 years with a capacity of 12 watts for 90 minutes. The emergency heads shall use miniature incandescent lamps of 6V 6W each. The unit shall be UL924 listed.

Note: This unit does not have remote capabilities. For units with remote capacity please refer to the DLM-2 series.
